## ANNOUNCEMENT

### TO ALL OFFICIAL PERSONS OF THE NATIONAL MEMBERS OF THE WFF

7<sup>th</sup> Fudokan world championship – Kluj-Napoca, Romania 2<sup>nd</sup> – 6<sup>th</sup> November  
2017

Dear Sir/Madam,

I want to inform you about strictly passed rules, as well as that in the future any failure to comply with these rules will not be tolerated. They are:

1. To any persons, regardless of their rank, position or status, attendance at the championship without adequate uniform, prescribed for such an occasion, will absolutely not be allowed.

Official persons at the championship will remove, without discussion, every person who is not dressed appropriately, especially since it presents itself as a form of discourtesy and disrespect.

2. All actors of the competition are warned that it will not be allowed to directly address the judges performing their duty, but instead every comment i.e. objection will be submitted to Kansa (official coach), before the start of the next match. Kansa solves the problem with the responsible controller. In the case that problem still cannot be solved at that moment, the controller addresses the Supreme Judge, who is, as a rule, the most competent to make the right decision. In the case that the problem is of such a nature that it touches the very essence of judicial rules the Supreme Judge convokes the Board of Judges which includes: the Supreme Judge and all the controllers.

1. The decision of the Board of Judges is definitive
2. The decision of the Supreme Judge is definitive
3. The decision of the controller, which does not require an intervention of the Supreme Judge, is definitive
4. The decision of Kansa, which does not require an intervention of the controller, is definitive
5. The decision of Sushin, which does not require an intervention of Kansa, is definitive
6. It would be more than desirable, considering that it is about Fudokan karate, for everyone, from cadets to veterans, to own and use Fudokan (Shinam) kimonos – For seniors, possession of this kimono is mandatory
7. Fudokan gloves (Shinam) are mandatory, from cadets to veterans, if they engage in kumite disciplines (Ko-go, Fuku-go, kumite)
